SIMPLIFIED PROCESS TO SELECT FOREIGN VISITING PROFESSORS

The Graduate Program in Economics (PPGE) of the Institute of Economics at the Universidade Federal do Rio de Janeiro (IE-UFRJ), invites applications from **overseas professors and researchers** for faculty positions at the level of **Visiting Professor**, in the terms and conditions herein described.

The Graduate Program offers **one (01) fellowship** for visiting professor to be filled in the year **2020**. Grantees will be selected by going through the simplified selection process following the submission of applications. The “Visiting Professor in Brazil” Fellowship was established to emphasize the importance of the need for international cooperation on research. The fellowships are supported by the Institutional Program for Internationalization (*Programa Institucional de Internacionalização -PRINT*) of the Coordenação de Aperfeiçoamento de Pessoal de Nível Superior (CAPES), according to:

1. GENERAL DESCRIPTION

1.1. We are looking for **one (01)** oversea professor and researcher to collaborate with the PPGE (UFRJ) colleagues and students in carrying out research through a short-term visit of **three (03) months**, which is expected to occur during the year of 2020, and may begin from July to September, 2020.

1.2. The selected visiting professor will be granted with one “**Visiting Professor in Brazil**” Fellowship, supported by the Institutional Program for Internationalization (Programa Institucional de Internacionalização -PRINT) of the Coordenação de Aperfeiçoamento de Pessoal de Nível Superior (CAPES).

1.3. The Visiting Professor is expected to offer open lectures and/or seminars for students; collaborate with Graduate courses offered by PPGE professors;

participate, conduct, develop and/or apply scientific research; co-supervision of master's and doctoral thesis; and intermediate the signing of agreements of academic technical and scientific cooperation with universities of his/her country.

2. APPLICATION

2.1. Applicants are required to submit the documents listed in item 2.3 to the following link:

2.2. The deadline for applications is **March 08, 2020**.

2.3. All documents must be in *.pdf* format. Documents to submit with the application:

- a) *Curriculum Vitae*;
- b) Updated ORCID record;
- c) Document attesting that the applicant has residence and is a researcher/professor who is employed at an overseas research institution or university;
- d) *Work plan* with the research areas of interest and planned activities for the period of one (1) month in Brazil, containing the following items:
 - i. Planned activities (courses, trainings, lectures and/or seminars);
 - ii. Motivation letter;
 - iii. Definition and clear delimitation of the research topics to be addressed in the activities;
 - iv. Objectives and expected outcomes from the visiting period;
 - v. Proposal of activities to be fulfilled after the period as a Visiting Professor in Brazil, in order to enhance UFRJ visibility and allow the expansion of agreements of academic technical and scientific cooperation with universities of his/her country.

3. APPLICATION EVALUATION CRITERIA

3.1. The application will be accepted for consideration by a committee, with members formally nominated by the Program's Deliberative Committee, that will evaluate the prerequisites listed in this call for applications and evaluate the merit of the work plan and its alignment to the research areas chosen by the candidate.

3.2 The committee will consider the following criteria:

- i. Adequacy of the application to the requirements established by Capes ordinance nº 289, of December 28, 2018, for the scholarships abroad and the CAPES-PrInt Notice, item 4.1.4 and its subitems for scholarships in the country, at the time of his/her application.
- ii. Adequacy of the application to the requirements of the simplified selection process.
- iii. Merit and scientific/technologic/innovative relevance.
- iv. Focus, clarity, consistency, coherence, appropriateness and feasibility of the proposal in relation to the timetable, objectives and results.
- v. Textual coherence, agreement between theoretical foundation and methodology.
- vi. Adequacy of the institution of origin and the technical-scientific relevance of the Visiting Professor from abroad to the activities to be developed at the Institute of Economics of UFRJ.

3.3 The result of the selection process and all the communications within the scope of this Call for applications, will be carried out in the page of the Institute of Economy of UFRJ: <http://www.ie.ufrj.br>.

3.4 The result of the selection process is scheduled for **March 9, 2020**.

4. COMPENSATION

4.1. The compensations of the selected visiting professor are exempt from income tax. The compensations are specified as follows:

- a) *Fellowship: R\$ 14,000.00 (per month).*
- b) *Air tickets;*
- c) *Installation assistance: R\$ 2,200.00.*
- d) *Health insurance: R\$ 400,00 (per month).*

4.2. Receiving these compensations does not create any institutional affiliation between the visiting professor and the Institute of Economics (UFRJ), being prohibited the exercise of any activity of an administrative nature and of representation.
