## CALL FOR APPLICATIONS, 2023 SIMPLIFIED PROCESS TO SELECT FOREIGN VISITING PROFESSORS

The Graduate Program in Economics (PPGE) of the Institute of Economics at the Federal University of Rio de Janeiro (IE-UFRJ) invites applications from **overseas professors and researchers** for faculty positions at the level of **Visiting Professor**, in the terms and conditions herein described.

The Graduate Program offers **1** (one) fellowship for visiting professor to be filled in the year **2023**. Grantees will be selected by going through the simplified selection process following the submission of applications. The fellowships are supported by the Institutional Program for Internationalization (*Programa Institucional de Internacionalização -PRINT*) of the CAPES Foundation, according to:

- Rules established by CAPES Notice no. 41/2017 (Edital CAPES-PrInt);
- CAPES Ordinance No. 01/2020 (Portaria CAPES);
- Regulation of the Graduate and Research Office (PR2) of the Federal University of Rio de Janeiro UFRJ;

#### 1. GENERAL DESCRIPTION

- 1.1. We have one position for a visiting professor at PPGE (UFRJ) for a three-month period, starting in July, August or September 2023. Candidates must be formally based at a university and/or research institution overseas.
- 1.2. The selected visiting professor will be granted one "Visiting Professor in Brazil" Fellowship.
- 1.3. The Visiting Professor is expected to offer open lectures and/or seminars for students; collaborate with Graduate courses offered by PPGE professors; develop research and collaborate with PPGE researchers; co-supervise master's and doctoral thesis; and/or contribute to establish partnerships between PPGE and their institution.

#### 2. APPLICATION

2.1. Application is free of charge and must be submitted by email to:

- 2.2. The application period goes from January 30<sup>rd</sup> to February 17<sup>th</sup>, 2023.
- 2.3. The following documents must be included in the application:
  - a) Personal information:
    - i. Full name
    - ii. CPF (if Brazilian) or passport number (for foreigners)
    - iii. Telephone number
    - iv. Email address
  - b) Curriculum Vitae;
  - b) Updated ORCID record;
  - c) Document attesting that the applicant has residence and is a researcher/professor based at an overseas research institution or university;
  - d) *Work plan* up to 1.000 words describing the planned activities for the period of 3 (three) months in Brazil, containing the following items:
    - i. Planned activities (including, but not limited to, courses, lectures and seminars);
    - ii. Motivation letter:
    - iii. Definition and clear delimitation of the research topics to be addressed in the activities;
    - iv. Objectives and expected outcomes of the visit;
    - v. Work schedule.
- 2.4 Documents and information indicated in the previous paragraph should be sent, if possible, in one only pdf file.

#### 3. APPLICATION EVALUATION CRITERIA

- 3.1. The application will be analyzed by a committee appointed by the Deliberative Committee of PPGF.
- 3.2 The committee will consider the following criteria:
  - i. Adequacy of the application to the requirements established by the Capes ordinance no 01/2020, and the CAPES-PrInt Notice, item 4.1.4 and its subitems for grants in Brazil.
  - ii. Adequacy of the application to the requirements of the simplified selection process.
  - iii. Merit and scientific/technologic/innovative relevance.
  - iv. Focus, clarity, consistency, coherence, appropriateness, and feasibility of the proposal with respect to the timetable and objectives.
  - v. Textual coherence, and agreement between theoretical foundation and methodology.
  - vi. Adequacy of the home institution and the technical-scientific relevance of the Visiting Professor to the activities to be developed at the Institute of Economics of UFRJ.
  - 3.3 The result of the selection process and all the communications within the scope of this Call for applications will be available in the webpage of the Institute of Economics: <a href="http://www.ie.ufrj.br">http://www.ie.ufrj.br</a>.
  - 3.4 The result of the selection process is scheduled for **February 24**th, **2023**.
  - 3.5 Applicants may appeal against the result of the selection process, presenting formal arguments by email until **February 27**<sup>th</sup>, **2023**.
  - 3.6 Final results, after the consideration of appeals, will be published on **February 28**th, **2023**.

### 4. COMPENSATION

- 4.1. The compensations are specified as follows:
  - a) Fellowship: BRL 14,000.00 (per month).
  - b) Air tickets (within a limit defined by Portaria Capes 01/2020);







- c) Installation assistance: BRL 2,200.00.
- d) Health insurance: BRL 400,00.
- 4.2. Receiving these compensations does not create any institutional affiliation between the visiting professor and the Institute of Economics (UFRJ). The visiting professor may not carry out administrative activities or any type of representation of the PPGE, the Institute of Economics, or the Federal University of Rio de Janeiro.
- 4.3. The compensations of the selected visiting professor are exempt from income tax.
- 4.4. If the visiting professor has a spouse or dependents that will come to Rio, additional compensations may be made available.
